# TERMS AND CONDITIONS

## CONTRACT

This contract represents the entire agreement between the parties and replaces all prior understandings (oral or written) covering the subject matter and can be changed only in writing signed by both parties. No firm booking can be made until both the signed Booking Contract and the deposit (if required) is received by **Adrian D. Griffin**.

## REPRODUCTION OF PERFORMANCE

Contractor acknowledges that Adrian D. Griffin is fully independent and completely in control of the design and content of his performance. The contractor cannot reproduce Adrian D. Griffin's performance by use of any type of audio recording equipment without the express written permission from Adrian D. Griffin.

## CANCELLATION

In the event of cancellation of the performance for which Adrian D. Griffin is responsible or for a reason originating with the artist or within his area of responsibility, Adrian D. Griffin is liable to the Contractor for the amount of the deposit (if required) only. In the event of cancellation of the performance for which the Contractor is responsible, the Contractor agrees to pay the artist 50% of the total performance fee or 150.00, whichever is the greater. The contractor all agrees to give no less than (7) days notice of cancellation of performance.

Should the artist fall ill, notification must be provided within 3 business days of the occurring illness. In this even, Adrian D. Griffin will be released from his obligation to perform on that date, and a make-up date shall be decided upon. Such make-up date must be within 2 months from the time of the date listed in the contract. Should Adrian D. Griffin fail to inform the contractor within 3 business days of the occurring illness, Adrian D. Griffin will be liable to the contractor for the amount of the deposit (if required).

## ADVERTISING

The Contractor shall be responsible for all matters pertaining to the promotion and production of the scheduled performance including but not limited to advertising and/or venue rental. Contractor agrees to reasonably promote the performance through its usual course of promotion and advertising efforts.
